Ms. Morrison provided a verbal and visual overview on the actions taken by GMIES and requested annual funding of \$10,000 per year for the next 3 years to assist with the goose control program.

Fraser Wilson, Nanaimo and Area Land Trust, re NALT activities and request for renewal of funding from the RDN.

Mr. Wilson provided a verbal summary on the actions taken by Nanaimo and Area Land Trust over the past year, and requested that the Board restore the funding to \$30,000 per year.
