UPDATE

On November 21, 2012 the Commission made a recommendation to the Regional Board for approval of an Electoral Area A Commission Grant-in-Aid of \$1,500 to St. Philip Anglican Church for the purchase of lightweight tables. Staff projected this grant would be expended from the 2012 budget. The Regional Board approved this grant at the Regional Board meeting on January 22, 2013 and consequently the funding was disbursed from the 2013 budget. As a result, the additional \$1,500 has been carried forward to the 2013 budget for approval.

Therefore, CFCS was asked to resubmit it for consideration in Winter 2013 round of applications. All applications met the grant criteria and are recommended for funding for a total of \$ 4,383.84.

I have attached the completed summary report and invoice for the paint, and the equipment to operate this type of floor paint. We are so pleased with the outcome. Pictures are enclosed.


