1. Increase the maximum accessory building floor area from 10 m² to 22.5 m² for one accessory building.
2. Reduce the maximum accessory building floor area from 6 m² each for any additional accessory building, accessory water storage structure, or accessory wood storage structure to a maximum combined floor area of 5.5 m².
3. Increase the maximum permitted height from 3.0 metres to 3.5 metres for an accessory building.

Nanaimo Recycling Exchange diverts more than 8,000 MT of material at low cost for the Regional District and the City of Nanaimo. March 31, 2018 may be the last day we can provide this service.

The NRE must re-locate. As there are no suitable existing facilities to rent or lease, this move requires construction of a new facility. New site and structure design is driven by strict requirements to conform to: environmental standards, Worksafe requirements, City of Nanaimo bylaws, and Waste Stream Management Licensing regulations, each of which is associated with significant cost.

From the time conversations about this issue began in 2012, with both the City of Nanaimo and RDN, the NRE has attempted to fund construction of a new facility in all possible ways including managing all debt, exploring partnerships with other local recycling organizations, and asking the City of Nanaimo and the Regional District of Nanaimo to contribute.

None of these options has produced a financially manageable result for the NRE. We have also explored less costly design options, but there are no options that comply with the strict regulations. Our latest construction budget, just received, is not manageable for us.

Over the years, meetings and delegations to the RDN Board of Directors and City of Nanaimo Council have achieved some progress in defining a role and funding model for the NRE, but conversations often stalled from uncertainty about jurisdiction and financial responsibility for solid waste services. It is fair to say that each entity has suggested the other pay; meanwhile, the NRE has been funding recycling services. The question remains whether the City and RDN choose to identify recyclable material as garbage for the landfill, or as diversion success.

The NRE would like to continue offering recycling and education services to the entire region, not just the City. Indeed, the model for community partnership should be further developed so people from Qualicum could have options other than travelling to the NRE. We share mutual goals: as regional partners we can achieve these goals.

Recycling makes sense. The provincial government's Zero Waste business case documents the importance of maintaining recycling facilities because reuse, remanufacturing, and recycling create more jobs than collection and landfilling. If the NRE closes, existing and potential employment opportunities end. If we have a new facility, employment opportunities increase.

The determination of the NRE's future cannot wait months, or even weeks. We are out of options. There doesn't seem to be a way for the depot to continue to operate without assistance at some level from local government.

We have been involved in discussions with both the City of Nanaimo and the RDN since 2012.

The Chair of the NRE Board of Directors, and the Executive Director of the NRE respectfully request your renewed attention to the future of Nanaimo Recycling Exchange, and we request a date and time to meet to discuss a solution.

In this respect I support Mr. Bleiker's and Ms. Termansen's July 12, 2017 letter. As well I would like to add my other concerns as well:

1. The endangerment of those community members who live along the routes that construction vehicles will have to take in order to reach the building site because of increased traffic. Presently walking/driving along those routes or getting out of driveways is already precarious.
2. The noise levels and pollution levels that will affect this community will take away from the healthy living environment that people who chose to live in the Fairwinds area very much appreciate.
3. The size and type of the buildings planned in 'Fairwinds Landing' will take away from the enjoyment of the area.
4. The renovations to the structure of the previous "hotel" will be done on a site that does not meet the 15 foot setback required by new buildings.
5. Use of water is already at a premium.
6. The planned condominium building would fit an urban area, but not a friendly, rural environment.
7. Residents need to stay within certain height restrictions in order not to affect their neighbour's view. The present building plans, though possibly legal, do not seem to care how the height of the buildings will affect the surrounding neighbours. This shows no consideration for those neighbours.

Greg,

I support, in principal, the redevelopment of the Schooner Cove area. Building an attractive village in the beautiful setting of Nanoose Bay would not only provide a hub for the local community, but also a truly attractive option for all in the Central Vancouver Island region for a day or an evening out. Further, it could be used to rejuvenate the image of the entire area to tourism, an area where much of the infrastructure supporting tourism is starting to show its age.

However, I have deep reservations over the current plan. Much of the plan appears to be hurried, poorly conceived and comes with a poor execution strategy. In short it represents a complete waste of an opportunity that is truly unique to the Nanaimo area, risking to send the area backwards rather than forwards. It smells of a cheap project, designed to maximise the short-term return to the developer with little regard to the long term interests of all who live in the area.

It is clear the previous plan was broadly popular with the local community, however it is also clear that the plan was ambitious, and presumably the projected economics of the project were marginal which I can only assume caused its demise. However, attractive, and well-thought out does not have to be expensive. The existing building, if structurally sound, could and should be re-modeled and not replaced – but tastefully. The remaining ugly high-rise development currently planned flies in the face of an area where (1) local residents have in many cases spent decades moulding an urban setting that is truly sympathetic to the local landscape and (2) newcomers have had to spend substantial sums of money to build properties of a style that maintains the look and feel of the neighbourhood.

In addition, while I like many in the community truly enjoy the forests behind the village, building the secondary access road through this land is imperative if a project of this size is to proceed at Schooner Cove. The safety aspects of bringing large construction equipment and supply trucks, not to mention construction contractors and eventually substantially more resident traffic down the existing narrow and windy road, shared with cyclists, pedestrians and an abundance of deer, is a recipe for disaster. In a recent meeting, assurances were made that a sidewalk would be constructed along the side of the road – but realistically this is impossible, there simply is not the space.

I therefore add my voice to those who strongly oppose the plan as currently conceived.

Dear Mr. Keller

I am writing to advise that I agree with the objections outlined in the July 12th letter of Ulrich Bleiker, and fully support the contents therein.

I further object to the proposed development for the following reasons:

- development to the extent that FW Enterprises intends will result in traffic congestion that the current road design cannot cope with.
- no provision appears to have been made to address what will be a critical water shortage in this region. We are already at level 3 restrictions and the summer is not even half over yet. The additional demands placed on our water supply by the increased usage of up to five condominium complexes cannot be met from our current water sources.
- I think it is unfairly prejudicial to existing land owners to allow the proposed development to proceed, not only as those immediately west and south of the development will suffer loss of amenities by the blocking of their former ocean views, but additionally as we will no doubt incur the additional infrastructure cost of the development such as additional fire department resources, new water storage and purification resources, upgraded roadways, and probably additional policing costs.

I fail to see how this change in the development could have been approved to this extent without addressing all of these issues.

I would like to make the following observations.

1. It appears that in the Neighbourhood Plan of 2011 that all the buildings were to be anywhere from 2 to 5 stories. The height should be not surprise anyone if they had reviewed the plan.
2. In the guidelines it was stipulated that no building would exceed 5 stories, but could be seven stories if two were below grade.
3. All of the renderings were labeled as "for illustration purposes only" which means that they were meaningless until final plans were drawn up.
4. The number of units was to be capped at 360, as near as I can figure out there will be 310 new units.

Now, aside from aesthetics, one of my observations is this. If the buildings were all 2 stories high then the footprint of the project would be 2.5 times larger than if they were 5 stories high. There would be no room left for anything. In order to fulfill the Bleiker vision there would have to be much less density. Much less density equals fewer units. Fewer units creates fixed costs that cannot be passed on to the reduced number of units. Developer cannot justify development, no development. No grocery store, no pub, no restaurant, no liquor store, no nothing.

Developer tears down what is left of old building.

Developer sells land.

New owner subdivides.

New owner shuts down marina, wants his own dock.

All access cut off.

Do not laugh at this, this could be an unintended consequence of this project failing.

Sometimes the devil you know is better than the devil you do not know.

So the question is should we not have this project or not?

In any event personal choices should be made on one's own investigation, not on what someone else has presented to them who may or may not be impartial to the situation.

My husband and I would like to express our strong support for the July 12th letter submitted to the RDN by Ulrich Bleiker and Margareta Termansen, concerning the Fairwinds Landing Phase 1Sc Development application.

My husband and I are in full agreement with Mr. Bleiker and Ms. Termansen's concerns.

We are most disappointed in the proposal submitted by Seacliff (now called FW Enterprises LTD.). We believe the existing proposal deviates from the original plan so much that (in the plan's current state) it is unacceptable. The proposal should, and must, be revised (with public consultation). I have been actively involved in the planning for Fairwinds over the last 8 or 9 years. As a former municipal engineer, urban planner and administrator it has been my pleasure to be part of one of the most exhaustive and inclusive approvals processes I have ever experienced, beginning with Concept Planning, Amendments to the Community Plan, Zoning By- Law Amendments and Phased Development Agreements.

Throughout this process, meticulous attention has been paid to Planning Act provisions and regulations as well as planning protocols approved by this Board. 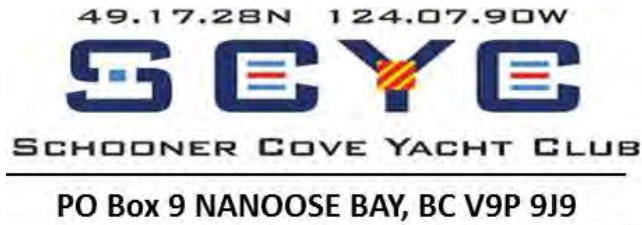
Re use of the existing building and the consequent modification of public waterfront access has already been addressed (will be addressed) by the Commodore of the Schooner Cove Yacht Club.
