SUMMARY

Regional Hospital Districts are required to approve an annual budget on or before March 31 each year.

A revised Nanaimo Regional Hospital District budget (attachment 1) shows \$7,409,526 (3.0% increase over 2017) in property tax revenues for 2018 which is unchanged from the preliminary budget provided in December. The budget does include a reallocation of some of the expenditures with \$3.16 million for capital equipment and minor capital projects at facilities in the Nanaimo Regional Hospital District (NRHD) area; \$2.82 million for debt payments in 2018 and a \$1.48 million transfer to reserve for future infrastructure projects. Bylaw 164 (attachment 2) requires approval to confirm the 2018 Hospital District Budget.

BACKGROUND

At the December 12, 2017 NRHD Board Meeting, the 2018 Regional Hospital District Provisional Budget was approved with the following components:

Property tax requisition	\$ 7,409,526
Capital grant allowance	\$ 3,444,055

Since that time, a formal annual capital grant funding request has been received from Island Health (Attachment 3) and incorporated into the attached revised 2018 budget and 2018-2022 projections document (Attachment 1).

The annual minor capital grant funding request from Island Health includes an unallocated portion of \$282,006. In the last few years, Island Health has not required the full funding envelope of \$3.4 million in annual capital grants and a portion of the grants has been used for major capital instead. For 2018 staff recommend a reallocation of the \$282,006 unallocated portion to the reserve fund transfer. This will result in a revised annual budget including the following components:

The current outstanding debt balance for the NRHD is \$27.4 million with retirement dates ranging from 2018 to 2037. The projects funded by this debt include the Oceanside Health Centre and the Emergency Room, cancer clinic/pharmacy renovations and the MRI replacement at Nanaimo Regional General Hospital. Presently, major capital projects planned by Island Health per their letter (Attachment 3) included in the budget that will require borrowing are as follows:

Other than the Electrical Energy Plant upgrade project, these are preliminary estimates for budgeting only. Island Health will present a formal funding request for these projects once their approvals and provincial funding are in place. At this time there are no other major projects proposed by Island Health; however, their long-term plan does include a new patient tower at the Nanaimo Regional General Hospital when funding becomes available. The 2018 revised budget includes a \$1.48 million transfer to a reserve fund established for significant projects such as the new patient tower.

ALTERNATIVES

1. Introduce and approve Bylaw No. 164 as presented for the 2018 Nanaimo Regional Hospital District Budget.
2. Make further changes to the annual budget and approve an amended bylaw.

FINANCIAL IMPLICATIONS

Alternative 1

2018 Revised Budget

The revised budget includes a 3.0% increase to the 2018 requisition (2017 = 3% increase). This will result in a tax requisition of \$7,409,526 for 2018 (2017 requisition = \$7,193,715). The estimated tax cost for 2018 is \$17.67 per \$100,000 based on 2018 assessments which is below the 2017 rate of \$19.94 as a result of increased assessment values throughout the region. Using average residential value across the NRHD area, the increase for the average home from 2017 to 2018 is \$3.50.

Preliminary results for 2017 indicate a surplus of approximately \$58,000 greater than planned largely due to timing of the Electrical Plant Upgrade project billings from Island Health and ongoing lower interim financing rates.

In the last few years, Island Health has not required the full funding envelope of \$3.4 million in annual minor capital grants and a portion of the grants has been used for major capital instead. For the 2018 revised budget, the annual grant has been adjusted to \$3,162,049 to match the list of planned projects and equipment purchases submitted by Island Health. The balance of \$282,006 shown as unallocated in the funding request is being reallocated to reserves for future infrastructure projects. This addition in 2018 will result in a total reserve balance of \$7.4 million increasing to \$11 million by 2022.

2019 to 2022 Budget Forecast

The outlook for future years in Attachment 1 has been revised based on updated information. The proposed increases to the tax requisition for 2019 to 2022 are estimated at 3% annually in order to ensure funding for Island Health capital plans will be available and to maintain reserve fund transfers. As noted above, the five year plan includes amounts for the Boiler Plant Redevelopment, a new MRI, and a new ICU; however, it does not currently include any specific funding in relation to a new patient tower which is a project Island Health is incorporating in their longer term plans.

The future projections include a projected growth factor for assessments of 1.5% (non-market change) from 2019-2022. Debt servicing costs are estimated to increase from \$2.8 million in 2018 to \$3.8 million in 2022. These amounts will continue to be revised as information is received from Island Health on capital project plans.

Alternative 2

A final budget must be approved by March 31 so any alternative direction would have to observe this deadline.

Re: 2018/19 Capital Projects and Equipment

I am writing to advise you of the Island Health 2018/19 capital plan for which NRHD cost-sharing is requested.

I understand the NRHD has approved a provisional 2018 budget of \$3,444,055 for minor capital projects and equipment. Island Health proposes the following allocation which we have itemized in the attached project and equipment lists:

Minor Capital Projects	\$2,222,213
Equipment	\$939,836
Unallocated Funding	\$282,006
Total:	\$3,444,055

The minor capital project list includes three Information Management/Information Technology (IMIT) projects. These three platform upgrades support the ongoing commitment to the Electronic Health Record. These systems are used Island Wide and are due for an upgrade. This upgrade will continue to support the functionality of the Electronic Health Record and will also add functionality to enhance care to patients by providing interoperability with provincial systems such as Pharmanet. This functionality will provide physicians with access to timely health record information. This means the patients within Island Health will continue to benefit from an electronic record to support their care for best possible patient outcomes. An allocation by RHD was determined based on a percentage of population (20% for NRHD).

Regarding major capital projects, Island Health plans to continue proceeding with redevelopment of the Nanaimo Regional General Hospital (NRGH) boiler plant and development of a second MRI at NRGH in 2018. In addition, Island Health continues to prioritize redevelopment of the NRGH Intensive Care Unit (ICU) as a high priority. The timing of the ICU project, however, is not yet known.
